The Hawaii Community Foundation helps people make a difference by inspiring the spirit of giving and by investing in people and solutions to benefit every island community.

The Foundation administers a number of grantmaking programs with targeted purposes or an island-based focus. The Foundation also assists several private foundations in delivering their grantmaking programs according to their specific strategies.

The Foundation's competitive grant programs include the following:

- **Community Grants**
These grants support project or program-based funding to nonprofit organizations benefiting the communities and people of Hawaii.
- **Organizational Capacity Building: Executive Transition**
These grants support nonprofit organizations during or soon after an executive transition process.
- **Promising Minds Initiative**
This program addresses the well-being and development of Hawaii's children under age five.
- **Sanford Harmony**
This initiative supports Hawaii schools serving students from preschool through sixth grade. The focus is on building peace and compassion through social and emotional learning.

This foundation supports a broad spectrum of programs and projects that benefit the people of Hawaii.

This foundation supports endeavors in the community that will make a significant difference in the betterment and welfare of the people of Hawaii.

This foundation supports projects that benefit the people of Maui County.
- [Victoria S. and Bradley L. Geist Foundation](#)
This foundation supports organizations that serve foster children and their families.
- Hawaii Children's Trust Fund: Child Abuse and Neglect Prevention
This program provides multi-year program support to nonprofit organizations that focus on protecting children through a family-strengthening program.
- Fresh Water Initiative
This program supports capacity building within nonprofit organizations to increase water conservation, recharge, and reuse.
- Community Restoration Partnership
This program provides support for on-the-ground lower watershed and coastal restoration projects in Hawaii that involve community stewardship activities and focus on durable sustainable impacts and nearshore marine areas.
- Kūpuna Aging in Place Program for Elderly Services
This program supports organizations that provide a range of supportive services, including community-based support services, adult day care and adult day health, and caregiver support services for low-to moderate-income kūpuna (seniors) and their caregivers so that kūpuna in Hawaii are able to age in place.
- Career Connected Learning
This program provides grants to strengthen the alignment between the diverse and growing number of STEM learning programs and the specific needs of Hawaii's STEM workforce in Hawaii County and Kauai County.
- Leahi Fund for Pulmonary Research
This Fund supports programs of research and education in, and the prevention of, pulmonary disease.
- Cecil "Guy" Marshall Fund
This fund supports schools that have established or are working to establish the International Baccalaureate World School program (IB) and also supports school administrators or board members who are interested in learning more about the IB program for their school.
- Oscar and Rosetta Fish Fund
This fund supports families who have children needing speech therapy.
- Family Literacy and Hawaii Pizza Hut Literacy
These grants increase access to and quality of literacy programs for Hawaii's residents. Focuses on families with young children (ages birth to eight) that offer programs that increase the educational achievement of both children and adults to improve the family's economic status over time.

- **Medical Research**
These grants support clinical and basic research in a variety of areas determined by the source of funding.
- **Tobacco Cessation**
These grants support nonprofit organizations on all islands to provide free smoking cessation services to Hawaii residents. The focus is on interventions and counseling for populations with the highest smoking prevalence rates, such as Native Hawaiians, persons with mental health and substance abuse challenges, LGBT communities, and low socio-economic status populations.
- **ESD Youth Prevention Program**
These grants seek to help prevent the initiation and use of Electronic Smoking Devices by youth under age 18.
- **Puna Strong**
This program supports community resilience for the Puna communities impacted by the 2018 Kīlauea eruption. The program takes a community-based disaster management approach that values the knowledge and capacities of residents; builds on local resources, including social capital; and aims to increase community resilience.
- **Network Leadership and Social Change**
This program supports networks that are working to create positive social change for their communities. Grants will range from \$10,000 to \$25,000 a year for two years, and should be used to support the operations of the network.
- **Young Children and Youth**
Supported by the Rev. Takie Okumura Family Fund, this grant program is focused on the healthy development of Hawaii's young children and youth. Proposals are accepted in the following areas of focus: promoting the healthy development of young children (birth to five years old) by supporting parents and other caregivers, including foster parents and grandparents, and strengthening the early care and education community systems, and addressing the needs of youth (six to 20 years old) by developing the ability to think critically, understand and appreciate one's own culture and those of others, and develop the ability to settle differences peacefully.

Occasionally, the Foundation issues requests for proposals targeting specific areas of interest.

Support is generally not provided to/for:

- endowments;
- loans;
- individuals (with the exception of scholarships programs)
- large capital projects (with rare exceptions); or,
- funding after an event has occurred.

Note: The Foundation also administers a number of scholarship programs for state residents.

The mission of the George Gund Foundation is to contribute to human well-being and the progress of society.

The Foundation invests in Cleveland, OH, with an eye toward building the sense of community—locally, nationally, and globally—that human progress requires.

The Foundation makes grants in the following program areas:

Climate and Environmental Justice

The focus is on projects and policies that contribute to the fight against climate change.

Support is provided for:

- organizations led by and serving communities of color and others who historically have been underrepresented and are the most vulnerable to the effects of climate change;
- organizations that develop and advocate for public policy on climate change and to advance clean energy, transportation, water, and air; and,
- organizations that work to mitigate climate change by promoting sustainable land use, creation of accessible greenspaces in Cleveland, and environmental justice.

Creative Culture and Arts

The focus is on promoting a vibrant, diverse, and thriving arts community in Cleveland that enhances learning, strengthens pride of place, creates an emotional connection to the environment, and deepens the impact of opportunities for those who might otherwise be denied them.

Support is provided for:

- organizations led by and serving people of color who have been historically underrepresented;
- the Cleveland Metropolitan School District's plan to help students realize their full creative and intellectual potential through rich artistic experiences; and,
- integrating the creative thought, energy, and inspiration that art can spark into the civic dialogue and sense of community that are needed to make progress on complex issues.

The Foundation seeks to balance support among Cleveland's legacy institutions and smaller emerging organizations that reflect the full breadth of Cleveland's culture and neighborhoods.

Public Education

The focus is on strengthening the power of public education and working to ensure every child in Cleveland attends a high-quality school and every neighborhood has a multitude of great schools from which families can choose.

The Foundation works primarily with the Cleveland Metropolitan School District and its partners to support schools that inspire joy and creativity, build resilience and character, impart and elicit knowledge, and produce just, kind, and engaged citizens ready for college, career, and civic life.

The Foundation is committed to the values of racial and economic justice and to overcoming the continuing issue of segregated schools and communities.

Thriving Families and Social Justice

The focus is on working toward a more just community and society that eliminate the conditions that create human need or limit fundamental rights.

Support is provided for:

- growth and development opportunities for historically marginalized people at critical life junctures, such as pre-natal and early childhood, adolescence, young adulthood, and when entering the workforce or forming a family;
- public policies that reduce poverty, that strengthen family economic stability, and that secure equitable access to basic human needs such as food, shelter, and healthcare—particularly primary, behavioral, and reproductive;
- equitable treatment for both juveniles and adults in the civil and criminal justice systems plagued by racial disparities; and,
- fair tax and fiscal policies which establish the framework for all public investment and the equitable use of data to accurately reflect the lived experience of society's most marginalized populations.

Vibrant Neighborhoods and Inclusive Economy

The focus is on working to achieve inclusive growth and opportunity for all of Cleveland's neighborhoods and residents.

Support is provided for:

- programs to address neighborhood walkability, bike-ability, and access to transit help to fight climate change; and,
- addressing barriers to opportunity such as lack of quality jobs, racial segregation, concentrated poverty, and underinvestment in diverse entrepreneurs through collaborative economic and community development efforts, including advocacy for policy change.

As part of the grant evaluation process, the Foundation asks that applicants provide insight into their thoughts and actions around three overarching issues:

- climate change;
- inequality and racial equity; and,
- threats to democracy.

The Foundation limits capital grants for construction or renovation to projects that seek U.S. Green Building Council LEED (Leadership in Energy and Environmental Design) certification.

Program-related investments are also offered to nonprofit organizations with a strong track record of performance using Foundation grants.

The Inasmuch Foundation primarily provides grants to nonprofit organizations in central Oklahoma, with some giving in the Colorado Springs, CO, area.

The Foundation's areas of interest include the following:

Education

The Foundation seeks to increase central Oklahoma's access to high-quality educational experiences that provides all learners with the ability to become informed, civically engaged, and productive members of their community. Specific areas of interest include:

- early childhood education, including high-quality early childhood education that promotes the physical, social, emotional, and intellectual development of young children; ensuring inclusive and equitable quality education that encourages lifelong learning; and encouraging family-based school readiness and early literacy development;
- K-12 education, including recruiting and retaining well-prepared, trauma-informed, culturally skilled, and committed teachers; implementing significant change in the culture and work processes of K-12 education; empowering children, teachers, and caregivers with the resources they need to

improve educational outcomes; engage in educational innovation to create high-performing public schools; and improving literacy rates of K-12 students; and,

- higher education, including engaging in partnerships to further the Foundation's initiatives in underserved Oklahoma communities; enhancing institutions of higher education through increasing higher ed access for minorities and postsecondary success; training and preparing the next generation of diverse faculty and academic leaders; provide professional employment and internship experiences to students; strengthening urban institutions of higher education; and workforce training and development.

Human Services

The Foundation seeks to strengthen individuals, families, and the entire central Oklahoma community by increasing access to social services and basic human needs. Specific areas of interest include:

- human needs, including combatting adult and youth homelessness utilizing the housing first model; fighting hunger and increasing access to healthy food options; empowering children and families to achieve long-term stability and well-being; transforming child welfare and foster care systems in central Oklahoma; supporting health awareness (healthy nutrition, medical services, and disease prevention); disaster relief and recovery; and eviction prevention;
- mental health and substance abuse, including promoting physical, social, emotional, and mental health and wellness; providing crisis intervention services for survivors of abuse and neglect; implementing trauma-informed programs of treatment, recovery, and hope; and advocating and protecting individuals from the risk of abuse and neglect; and,
- criminal justice reform, including diversion programs; challenging racial disparity; reducing prison population through sentencing reform; and workforce and skills training for individuals exiting the criminal justice system.

Community

The Foundation seeks to improve central Oklahoma's quality of life by promoting cultural experiences, recreation, tourism, entrepreneurship, and economic development. Specific areas of interest include:

- arts, culture, and recreation, including enhancing parks, recreational, and cultural services; programs that foster creativity in the areas of music, visual, and performing arts; preserving and maintaining natural assets and cultural amenities; and expanding access to community-centered arts and culture;
- entrepreneurship and innovation, including developing an active entrepreneurial and innovative environment; growing existing industries and supporting business accelerators; social entrepreneurship; and,
- broader community initiatives, including promoting social justice and racial equity.

Journalism

The Foundation is committed to supporting ethics and excellence in journalism through the following focus areas:

- building sustainable business and revenue models;

- striving for a balance of individual memberships/subscriptions, corporate sponsorship and advertising, and philanthropic support;
- committing to a public-service orientation, reflective of the unique diversity and culture of Oklahoma;
- engaging in authentic dialogue with the communities they serve and cover issues that matter to Oklahomans, ranging from holding government accountable to elevating under-represented voices;
- providing technical support, professional development, and resources for innovation to better meet the information needs of all Oklahomans;
- increasing the quantity, quality, and ethical standards of investigative reporting and watchdog journalism on state and local issues within the United States; and,
- stimulating and nurturing the development of organizations, infrastructures, services, collaborations, and business models that can help secure a future for investigative reporting and watchdog journalism.

Types of support include:

- project support;
- general operating support;
- building funds; and,
- equipment.

No grants are given to for-profit organizations, individuals, or endowments.
